This statement describes how we collect and use your information and the rights that you have regarding your information.

We may collect information about your preferences from you when you visit this website, when you request information from us, or when you use our services.

By using any of our services, including this website, and by providing us with any personal information, you consent to the use of your personal information in the manner described in this Statement. Please do not send us any personal information you do not wish to be used in this way.

References in this statement to “your information” also refer to the personal information that you provide to us. LAZARD is the data controller for all information transmitted through this website, and our contact information is provided below.

INFORMATION THAT WE COLLECT

LAZARD may request and collect identifying information or other information from you at certain times through this website. Depending on the information and/or services that you request, you may be asked to provide us with your name, e-mail address, and other information. In addition to the information that you voluntarily submit to us, LAZARD collects the domain names and IP addresses of its visitors, as well as usage statistics (such as Internet browser types and operating systems used) and browsing history. We use such data for the purpose of promoting our services. LAZARD may associate this information with information to identify the person concerned and other information that it collects.

HOW WE USE YOUR INFORMATION
